## Additional Information:

Language services requested outside of the normal business hours will be done telephonically.
- Language access services for lesser used languages: When possible CITS will provide in person interpreting
  services for lesser used languages. To ensure the timeliness and quality of interpretation services if we are unable to
  secure an in-person interpreter, the interpretation requests will be served through a third party providing professional
  remote interpretation services. Language services requested outside of the normal business hours will be done
  telephonically.
- All requests for interpretation services must be submitted to the Court Interpretation and Translation Services
  as soon as possible. Due to the high demand for interpretation services, if CITS does not receive your request
  in a timely manner, this office might not be able to make arrangements to have an in person interpreter available
  for you on the date and time requested; we may be able to arrange for a telephonic interpreter.

The interpretation services provided by CITS are exclusively for clients of the Pima County Superior Court who do not speak English as their primary language, who require the assistance of an interpreter in connection with court hearings, programs or services. Please let us know if you do not receive an automated interpretation services confirmation email from CITS.
